

Notification Regarding the Status of
Repurchase of Shares of Common Stock

Tokyo, December 3, 2024 — Hitachi, Ltd. (TSE:6501) today announced the status of repurchase of its own common stock pursuant to Article 459, Paragraph 1 of the Companies Act of Japan and Article 32 of Hitachi's Articles of Incorporation, which was approved at the Board of Directors meeting held on April 26, 2024, as follows.

1. Class of shares repurchased	Common stock of Hitachi
2. Total number of shares repurchased	6,887,400 shares
3. Total purchase price for repurchased shares	26,442,440,605 yen
4. Period of repurchase	November 1, 2024 to November 30, 2024
5. Method of repurchase	Open market purchase through the Tokyo Stock Exchange
