Hitachi Announces Plan on Year-end Dividend

Tokyo, April 28, 2025 Hitachi, Ltd. (TSE:6501, "Hitachi") today today announced that the Board of Directors decided on a plan for the year-end dividend for the fiscal year ended March 31, 2025, which had not been decided, as shown below in view of earnings performance and other factors. The year-end dividend is scheduled to be finally authorized by the Board of Directors in May 2025.
